FINANCIAL COMMITMENT & FREQUENTLY ASKED QUESTIONS

What is my financial commitment to participate?

Participation in the Miss Pueblo County Scholarship Pageant requires the following:

- **\$50.00 Registration/Application Fee** (non-refundable – due at submission)
- **\$150.00 Sponsorship Fee**
(May be from a business, family member, or individual)
- **\$400.00 Program Book Advertising Fee** (mandatory)
(Business advertisement or salute page)
- **Sale of ten (10) Pageant tickets at \$12.00 each**

Total Financial Commitment: \$600.00

This total includes the registration fee, sponsorship fee with program book recognition, and mandatory advertising requirement.

How can these fees be fulfilled?

The Pageant is structured so that required fees may be fulfilled through sponsorships, advertising sales, or fundraising efforts. Many pageant families successfully meet their financial obligations using these methods.

Program Book Advertising Rates

- Business card size – \$45.00
- ¼ page – \$60.00
- ½ page – \$80.00
- Full page – \$130.00

Sponsorship and advertising fees help offset Pageant production costs including insurance, awards, venue rental, production expenses, staffing, printed materials, scholarships, and administrative support.

All registration, sponsorship, ticket, and advertising fees are non-refundable without exception.

For the safety and well-being of all contestants, **any medical condition, allergy, disability, or health concern requiring special accommodations must be disclosed in writing to the Pageant Director** at the time of registration or as soon as the condition becomes known, including sensitivities to lighting, sound, physical activity, or stage effects. Disclosure to a volunteer, staff member, judge, emcee, or any third party **does not constitute official notification**.

The Pageant Organization will make reasonable efforts to accommodate disclosed conditions when timely notice is provided; however, failure to properly notify the Pageant Director may limit or prevent accommodations, and the Pageant Organization shall not be held responsible for accommodations that could not reasonably be implemented due to lack of notice.
